

DaiM Florida Launch Giveaway — Full Terms & Conditions

1) Sponsor

This promotion (“Giveaway”) is sponsored by **Sage Forum Inc.** (“Sponsor”). DaiM is a product of Sage Forum Inc.

2) No Affiliation

This Giveaway is **not sponsored by, endorsed by, administered by, or associated with** The Florida Bar, any Florida court, any mediator certification authority, or any government entity.

3) Eligibility

To be eligible to enter and win, a participant must:

- Be one of the following Florida professionals:
 - A **Certified Mediator**, or
 - A **Family Law Practitioner** (active member **licensed by The Florida Bar**)
- Complete the DaiM onboarding requirement **during the 25-day free trial** by doing the following:
